In case of any holiday on the day of opening, the limited tenders will be opened on the next working day at the same time as scheduled above.

### 1. Eligibility criteria (copy should be submitted As per Annexure-IA) for following:

- GST Certificate should be submitted.
- PAN card
- Valid Certificate of Pharmaceutical Products (COPP)/ WHO GMP Certificate/GLP Certificate and Valid FDA License.
- The bidder must be manufacturer or in case of authorized distributors/agent/ stockist should accompany a letter of Authority from the manufacturer authorizing item to quote for the drugs.
- EMD (FDR with validity of six months) as under separately has been uploaded by tenderer Rs.10,000/- (Rupees Ten Thousand Only). EMD must be in the form of FDR in favour of "**The Project Director, Uttar Pradesh State AIDS Control Society payable at Lucknow**" drawn at any schedule commercial bank / nationalized bank.
- Firm/Agency/organization must have minimum average turnover of Rs. 15 Lacs for last three years. The said turnover must be for consecutively for last three financial years. Last three years turnover authenticated & certified by CA be submitted alongwith the said tender.
- Self-declaration on firm letter head that the company is not black listed by any Ministry/Dept. of GOI/State Govt./Organization on attached format in technical bid.
